- Sample
- Includes 240 companies in the S\&P 500 (companies with published compensation data for 2011-2013 as of April 30, 2014)
- Data are shown both for the entire sample, S\&P 100 companies (itself a recognized index), and Other 400 companies (those companies in the S\&P 500 that are not in the S\&P 100)
- Methodology
- Year-over-year data are shown on a "constant company" basis, not median-to-median
- Mandatory deferrals of Short-Term Incentives are included in Long-Term Incentives
- Performance awards valued on the basis of Target (when both Target and Maximum are disclosed) or $80 \%$ of Target or Maximum (when only Target or Maximum is disclosed)
